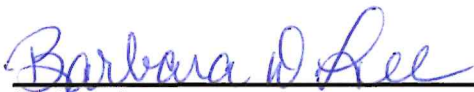
If you wish to make a general public comment or to comment on a specific agenda item, the following methods are available: In person during the public comment period or via zoom; limited to 3-minutes.
